Recognition Certificate for the school under sub rule (5) of rule 9 of right of children to free and Compulsory Education Rules, 2011 for the purpose of sub section - (2) of section 18 Right of Children to Free and Compulsory Education Act, 2009.

Dear Sir/Madam,

With reference to your application dated 20/03/2013 and subsequent correspondence with the school, I convey the grant for provisional recognition to the Sahel Bhatat Singh Memorial Public School, Majhera (Name of school) for 1st to Class 8th for a period of Five Year w.e.f. 01-04-13 to 31-03-2018.

The above sanction is subject to fulfilment of following conditions:-

1. The grant for recognition is not expendable and does not in any way imply any obligation to recognize or affiliate the school beyond Class VIII.
2. The school shall abide by the provision of Right of Children to free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2011 (Annexure II).
3. The Society/School shall not collect any capitation fee and subject the Child or his or her/parents guardians to any screening procedure.
4. The School shall not deny admission to any Child:
 - (i) For lack of age proof,
 - (ii) If such admission is sought subsequent to the extended period of ninety days for admission, and
 - (iii) On the ground of religion, caste or race, place of birth or any of them.
5. The School shall ensure that,
 - (i) No Child admission shall be held back in any class or expelled from school till the completion of Elementary Education in that School.
 - (ii) No Child shall be subjected to physical punishment or mental harassment.
 - (iii) No Child is required to pass any Board examination till the completion of Elementary Education.
 - (iv) Every Child completion Elementary Education is awarded a certificate as laid down under rules 19 of the Right of Children to Free and Compulsory Education, Himachal Pradesh Rules, 2011.
 - (v) Student with disabilities/ special needs are admission as per provision of the Act.
 - (vi) The teachers are recruited with minimum qualifications as laid down under section 23(1) of the Act. The current teachers who, at the commencement of this Act did not possess minimum qualifications shall acquire such minimum qualification by March, 2015.
 - (vii) The teacher performs his/her duties specified under section 24(1) of the Act, and
 - (viii) The teacher shall not engage himself or herself for private teaching activities.
6. The School shall follow the syllabus on the basis of curriculum laid down by academic authority under sub-section (1) of section 29.
